1. NGS updates

- a. Height Modernization (Gallagher/Fromhertz) Western Regional Webinar was held on Nov 19, and over 250 people attended. The meeting materials, presentations/videos, and a final report will be posted online by the end of December.
- **b.** Height Modernization (Gallagher) annual face-to-face meeting will be April 29-30, 2014 in Mobile, AL and save the date will be distributed in December

2. State Updates

- a. Minnesota (Zenk) OPUS Projects Training will be held in Shoreview, MN on Dec 10-12
- **b.** South Carolina (Woods) South Carolina Geodetic Survey is wrapping up a large 3 county HMOD project, as well as 2 smaller projects. Also, NGS decision to limit access to 'Neptune' has presented significant challenges. Specifically, (a) it enabled a check between afiles created manually and through WinDesc, (b) it allowed the use of Cluster to show shifts in different adjustments which saved a lot of time, (c) it assisted finding the L number used to create the elevation on a known station, which is needed when the benchmark elevation is not on the datasheet, and (d) it allowed another place to save final bluebook files. Dick will follow up with Christine and Janet Irwin after the meeting, so NGS can follow-up accordingly.

c. Great Lakes (Beaverson) – the Great Lakes Regional Consortium will be participating in the WI Society of Land Surveyors meeting January 22-24 in Wisconsin Dells, WI and at the Illinois Professional Land Surveyors Annual Conference February 13-15 in Springfield, IL.

3. Height Modernization Strategic Plan Update

Christine Gallagher, National Geodetic Survey

In December 2012, NGS approved a strategic plan to help coordinate efforts and prioritize projects in order to advance the goals of the National Height Modernization Program. This presentation will evaluate the past year's progress implementing the strategic plan. Additionally, it will highlight relevant successes or challenges, and discuss priorities for the near future.

Speaker background: Christine Gallagher is a Program Analyst from the National Geodetic Survey (NGS), and she has worked with the National Height Modernization Program since 2009.

Presentation summary:

- Height Mod Plan aligns with NGS ten-year plan, but it does not currently designated resources or milestones.
- Some actions have experienced significant progress while others have not been significantly started yet.
- Areas to improve include identifying, prioritizing, and recommending how to fill gaps/weaknesses (especially in areas with vertical motion). We also need to continue to have stronger coordination with our partners to implement efforts like pilot projects.
- Major accomplishments include the 2013 partner meeting, starting a GNSS Derived Heights to update NGS 58-59, and collaboration with COMET for outreach and distance learning.
- Related programs/projects like GRAV-D and OPUS-Projects continue to progress.

Questions/answers:

Q (Carlson): When will GRAV-D come to HI?

A (Gallagher): It continues to change based on resources and other factors, so the GRAV-D team needs to be consulted for the exact answer.

Q (Gallagher): Is an update on progress of the Height Mod plan helpful? **A** (Beaverson): Yes - definitely.
