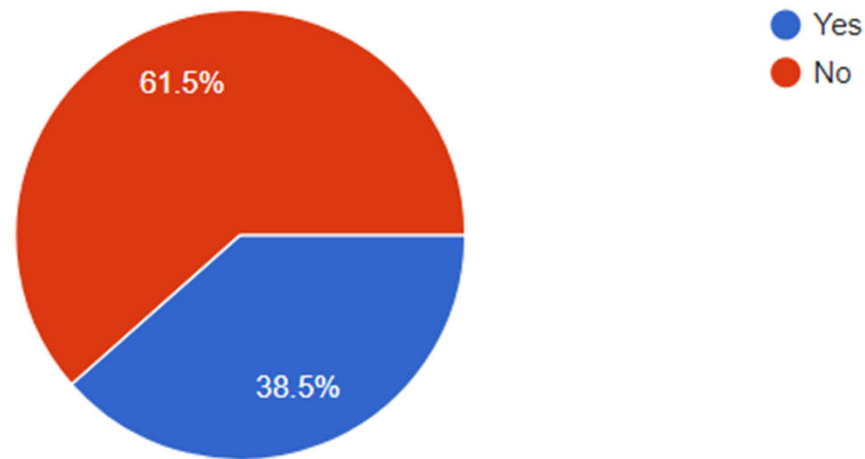

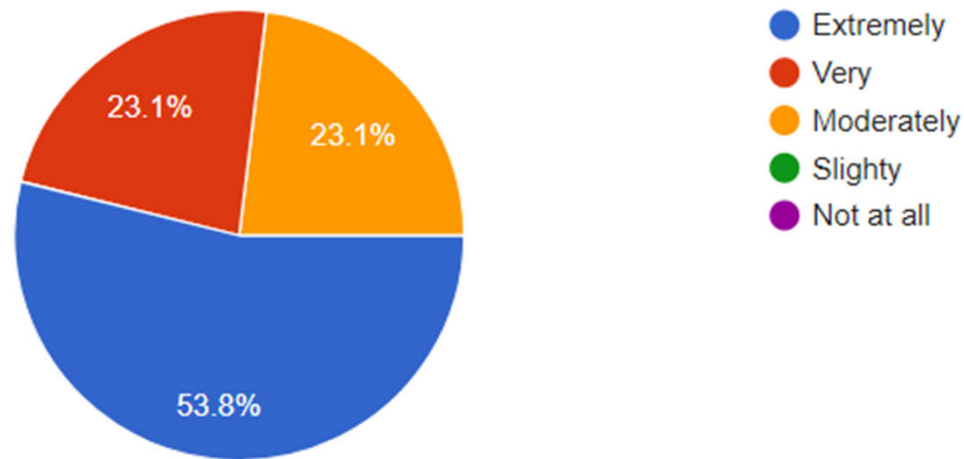

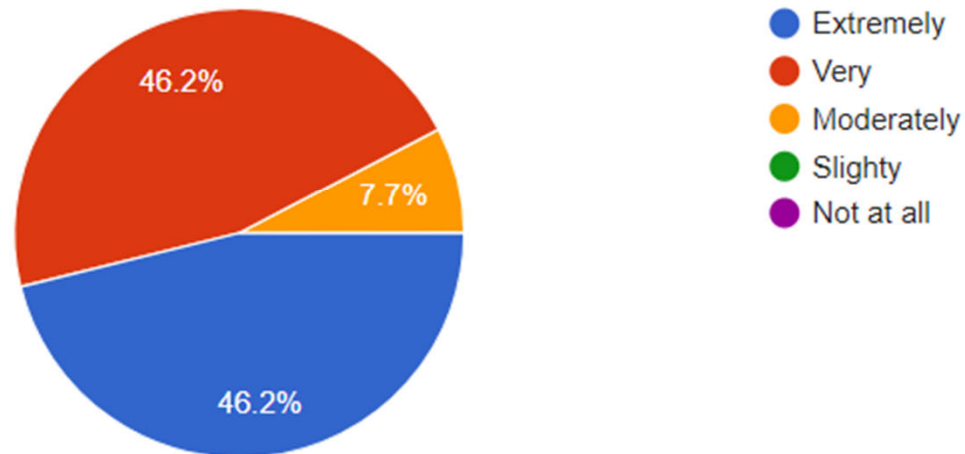

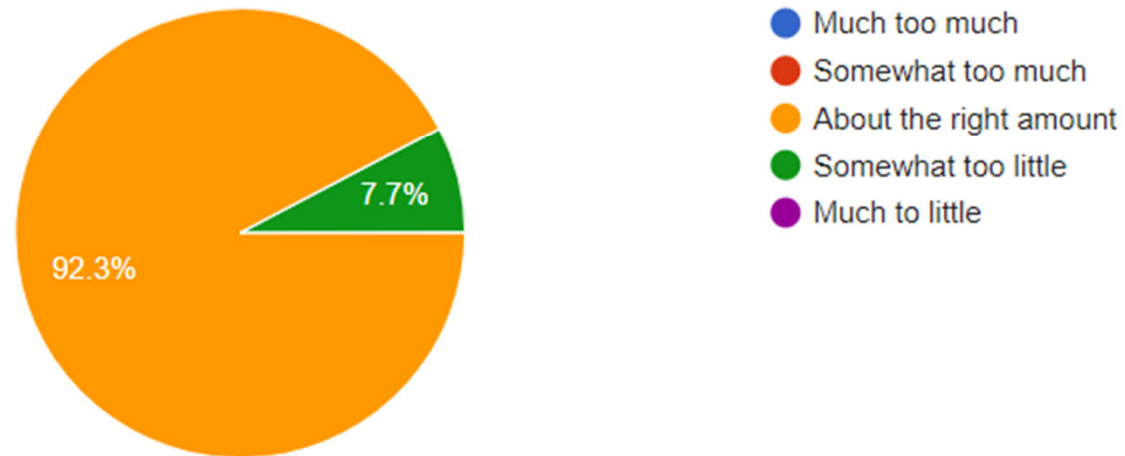

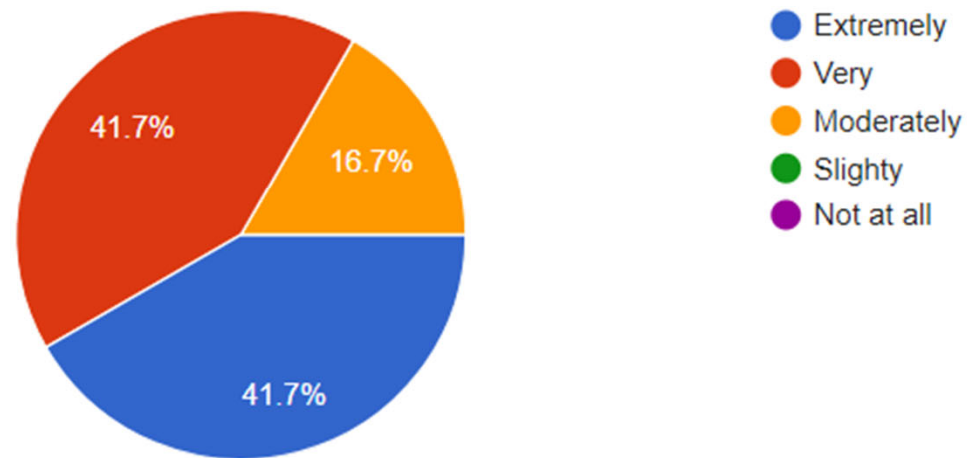

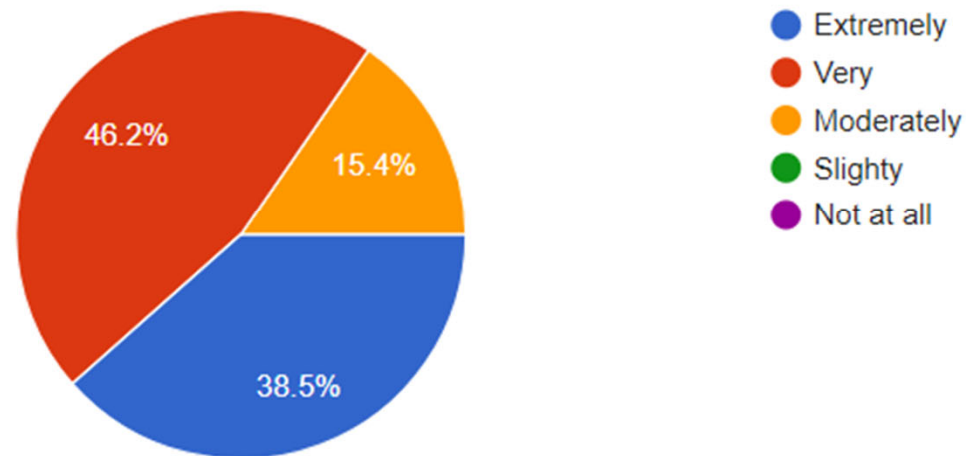

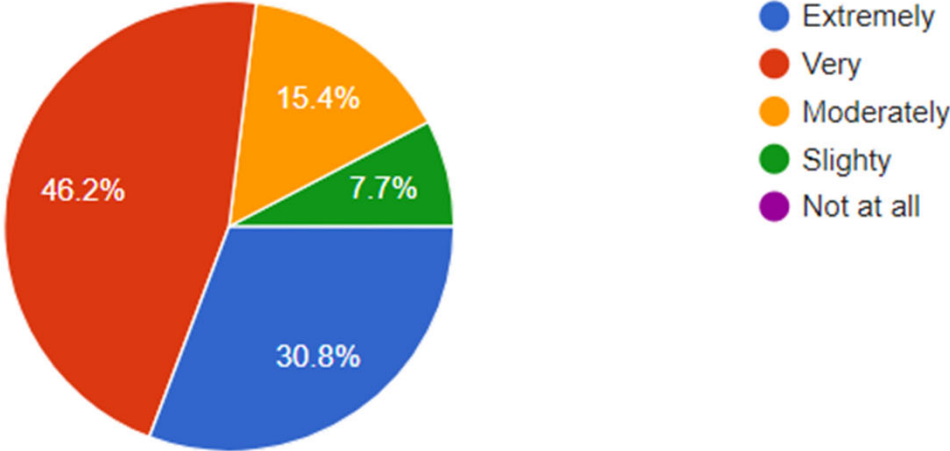

# 8. How beneficial was the information on Science, Decisions and Definitions?

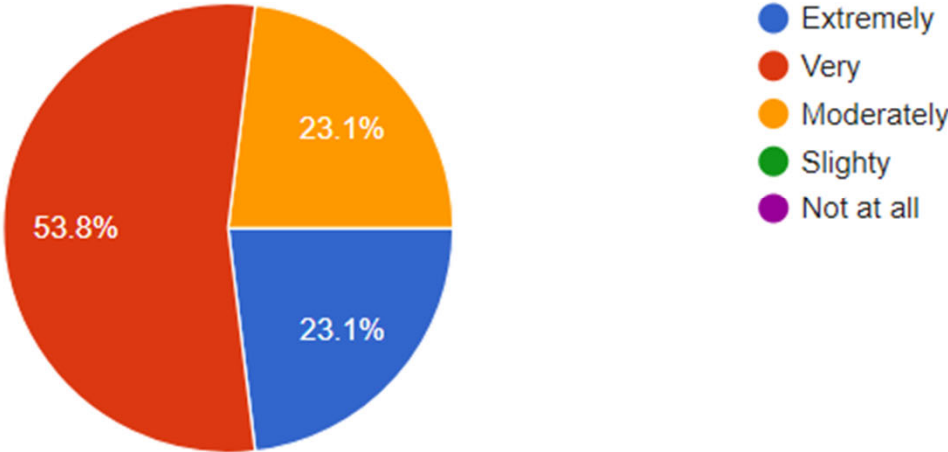

# 9. How beneficial was the information on End Users Perspectives?

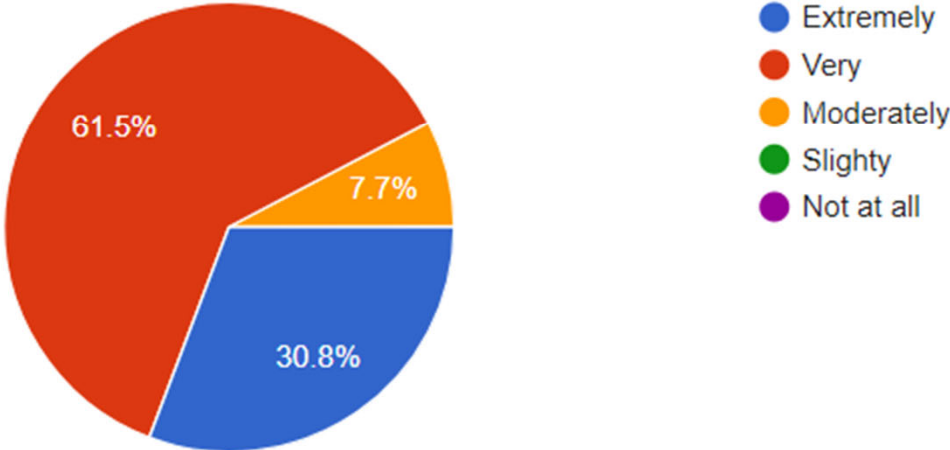

# 10. How beneficial was the information on Putting the Science into Production?

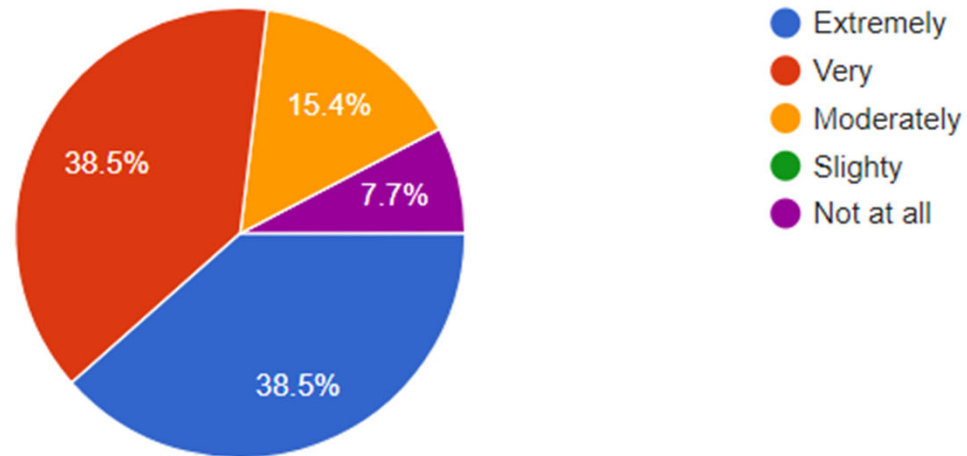

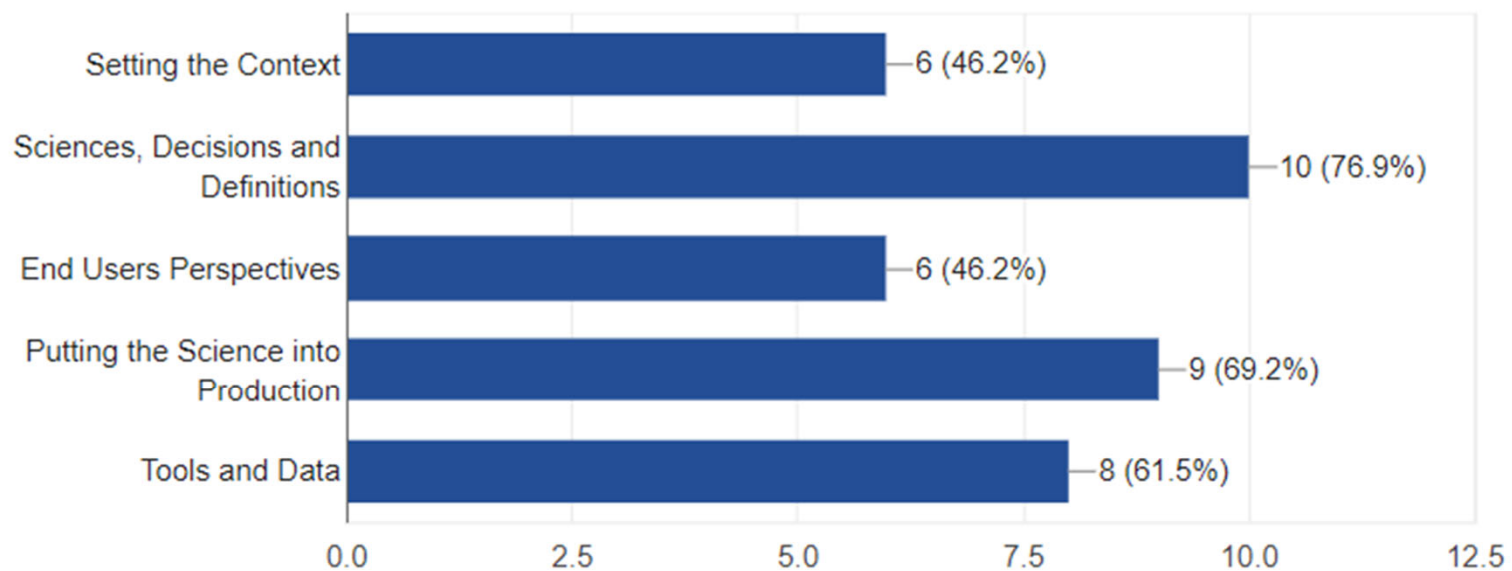
